

## Terms & Conditions

Please ensure that you have read our Terms and Condition before applying for the Advisory Board Assessment Process.

2. Assessment Goal:

To provide a unbiased assessment or artiste's eligibility for potential onboarding of artistes with Sonic Octaves Pvt. Ltd. for a potential of creating a recording with Sonic Octaves Pvt. Ltd. (hereafter called as Company)

3. Artiste Eligibility:

All applicants are not below the age of 18 (eighteen) years. If the application is done for the minor then, site assumes that the guardian or parent of the minor makes this application and they have full authority to do so in the name and on behalf of the minor applicant.

4. Assessment Process:

a. After the application is submitted, only the audio clip is forwarded to the Advisory Board Panel, which consist of number of advisory board members. Company reserves its right not to disclose the number and /or the names of the advisory board members at any point of time.

b. Company reserves the right of not sharing the names of the applicants to the Advisory Board Members and also shares the right not to disclose the identity of the Advisory Board Members either to the applicants or the Advisory Board Members interese.

c. Information submitted with the audio clips is used only for the purpose of the administration of the assessment process. It is generally not shared with the advisory board members with a view to maintain unbiased nature of this process. However, company does reserve the right of decision as to whom to share other information details of the applicant submitted during this application, on a case to case basis and if disclosure of such information encourages effective execution and/or achievement of goal of this process.

d. Assessment process is kept as much anonymous/unbiased as possible at all stages both for the Assessors and Assessed. The clips uploaded with these applications are shared digitally with the assessors without the informationage/gender/guru/teacher/gharana/or any other such information.

e. Assessors provide their feedback on the clips they hear and rate the artistes based on the criteria shared with them for effective assessment. Company reserves its right not to disclose the criteria to anyone other than concerned parties, at any point of time.

f. Upon receipt of feedback and/or rating from all the related Assessors assigned to evaluate a particular clip and/or all clips of an artiste, artiste would be communicated with the outcome of assessment either verbally or via electronic medium, which includes but not limited to email communication.

g. If outcome of the assessment is positive then artiste would be contacted by the right personnel in the Company for further steps to associate artiste with the company and that the process of assessment is closed for any application at this point of time.

5. Successful Applicants will be selected at the sole discretion of the Company, notwithstanding the feedback and ratings from the Assessors. However Company reserves the right to take final decision which will be binding upon all Applicants. .
